### Logo

You should choose a transfer that can be heated to a maximum of 145 degrees when being printed onto the product. Remember to check the washing instructions for the chosen transfer before washing the product.

The product is certified with a maximum logo area of 0,0300m<sup>2</sup>. This approved area must not be exceeded. Logos respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. Note: The listed area is only a guide to how much space is available for logo placement. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

### Logo placement:

- Workwear logo stretch. Over left breast pocket. Max 9x3 cm/3.5x1.1 inches

- Workwear logo stretch. Right breast pocket. Max 8x7 cm/3.1x2.7 inch
- Workwear logo stretch. Mid-back. Max 20x20 cm/7.8x7.8 inches
- Workwear logo stretch. Horizontal on right sleeve. Max 10x5 cm/3.9x1.9 inches
