### Logo

The product is certified with a maximum logo area of (L-5XL) 0,0400 m², (XS-M) 0,1500m². This approved area must not be exceeded. Logos respectively on the front or back of the product, can only constitute a maximum of 50% of the total approved logo area in order to maintain the EN ISO 20471-certification. Note: The listed area is only a guide to how much space is available for logo placement. In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

- Workwear logo stretch. Horizontal on right sleeve. Max 10x5 cm/3.9x1.9 inches
