Logo

- Workwear logo stretch. Right breast pocket. Max 8x7 cm/3.1x2.7 inch
- Workwear logo stretch. Mid-back. Max 20x20 cm/7.8x7.8 inches
- Workwear logo stretch. Horizontal on right sleeve. Max 10x5 cm/3.9x1.9 inches
