TECHNICAL DATA SHEET

ProSolve Temporary Line Marker (all colours)

DESCRIPTION

Temporary Marker paint is an ECO friendly water-based marking paint formulated for application on concrete, tarmac, wood and composites, this water-based product is ideal for local authorities, contractors and utility companies who do not wish paint marks to remain upon works completion.

Can be used in ProSolve Hand Applicator as well as the two and four-wheels applicators.

QUALITY AND PROPERTIES

Water-based

Easy to wash away after use

High coverage and quick drying

Suitable for use on hard surfaces (tarmac, concrete, brick etc), grass etc

The durability of the marking depends on the surface as well as location, weather conditions and traffic. It could last a few days to a few weeks without been washed away.

Storage: 5 years shelf life from the date of manufacturer.

Size: 750 ml

Coverage: Depends on conditions, type of surface and density of application, but 750ml is sufficient for approx. 50m of a 50mm (2") width line.

Drying (at 20°C, 50% relative air humidity). Touch dry in 20-30 minutes. The drying time depends on temperature of surroundings, air humidity and thickness of the applied layer.

DIRECTIONS FOR USE

SHAKE THE CAN WELL BEFORE USE.

Ensure surface to be marked is clean, dry and free from oil and grease.

Shake can vigorously until agitator ball inside can moves freely for one minute.

To clean nozzle after use, turn can upright and depress for 3-4 seconds.

Use water and a brush to remove any markings although the paint will fade naturally over a number of weeks.

DISPOSAL

Although water based, please do not dispose of wet unused liquid paint into watercourses. Waste materials must be disposed of in accordance with the Environmental Protection Act 1990 and relevant regulations made there under. For further information contact the Environment Office at your local council.
